

## **Administrative Updates**

### **Personal Protective Equipment Inventory Process**

It is the responsibility of Materials Management to manage the replenishment of inventory stored within the storeroom (central supply) as well as manage the replenishment of inventory at various patient care areas. Inventory will be replenished according to the established stock par levels.

Storeroom personnel are responsible for replenishing stock to the PPE cage locations daily. The storeroom personnel will pick the items from central supply storeroom accordingly, distribute to PPE inventory cages, and signature will be required upon delivery by management.

PPE Inventory cages will be in designated locations with PPE and secured with lock. A key will be issued to management only; unit management must assure the key is given to each shift and not shared with employees. It is the responsibility of the designated manager/supervisor of the shift to distribute/replenish the supplies to isolation cart as needed. *Management is responsible for the issuance and security of all PPE supplies once delivered.* 

#### **Distribution of PPE:**

<u>Non-patient units</u>: Personnel will request PPE directly from storeroom when needed. A storeroom requisition form must be completely filled out and signed by manager before items are issued. \*\*only issued approved par level amounts

<u>Patient units</u>: PPE will no longer be stocked in the inventory areas, will only be stocked in the secured cages. No PPE will be distributed without a signature from management.

PPE consist of but not limited to:

- Isolation Gown
- N95 Mask (regular and small)
- Isolation Mask

- Gloves (small, medium, large, Xlarge)
- Eye shield
- Mask w/shield

The yellow isolation cart will be issued on an as needed basis as mobile storage for PPE. The isolation carts contents are below:

- QTY. 60 -yellow isolation gowns
- QTY. 1- box large gloves
- QTY. 1 -box medium gloves
- QTY. 1 -disposable stethoscope
- QTY. 1 -disposable blood pressure cup
- QTY. 6 -disposable thermometers
- QTY 50- isolation mask

Specifically, the locations are the west side of 13<sup>th</sup> Street SE from the second entrance to Varney Street SE and Southern Ave opposite of the hospital. 

- Employees may use an app on their phone or call directly




## **Transportation Cont.**

Uber has partnered with DCHA to provide free transportation for health care workers. Managers, please share the attached documents with your employees and post them in your break rooms.

#### **Program Details:**

- Each week employees can access the Uber promo code via the following link: <a href="https://r.uber.com/cdTeela5IW">https://r.uber.com/cdTeela5IW</a>
- Once downloaded employees can use their Uber account as they normally would, and the credits will automatically apply
- Rides are valid from 9 pm 1 am every day and 5 am 8 am on weekends
- Trips must begin or end at UMC hospital entrance
- Each trip is valid for up to \$25; balance owed by each passenger
- Health care workers are required to show their hospital badge and wear a face mask when ride sharing


